

## Vedanta employees volunteer to work at and contribute for Kerala flood relief camps

10<sup>th</sup> September 2018, New Delhi: The employees of Vedanta have been volunteering to help at Kerala floor relief camps. Continuing their efforts of flood relief and rehabilitation, the employees of Vedanta have donated one day's salary towards the Chief Ministers Fund. Tamara – I, and was delivered to the Adoor collection centre at Pathanamthitta – one of the worst affected areas in Kerala. The volunteers helped unload and arrange the products at the collection centre for distribution.
