MSME definition to be widened further: Gadkari

THERE WERE about 6.34 crore MSMEs in India, of which 6.3 crore are micro units, while 3.31 lakh were small businesses and 5,000 medium enterprises, according to the NSS survey during 2015-16. The MSME status brings businesses certain assorted benefits — including the

businesses certain assorted benefits — including the mandatory 25% official pro-curement and loans under the priority sector lending scheme —apart from periodic govern-ment and regulatory relief. lowed by Air India for its spe-cial flights meant to bring back Indians stranded abroad due to the pandemic. Besides, the top court directed that Air India and other airlines will have to fol-low the interim order given by the HC with regard to safety measures. The HC will now consider the plea on

Both the Centre and Air India had moved against the SC against the HC order. The Solicitor General told the apex court that the DGCA circular of March 23 applied only to scheduled domestic lights and not non-sched-uled international. Air India also argued that the Manch 33 circular has been superseded by a new circular of May 22, 2020 that permitted domestic flights to operate from May 25 and there was no express mandate to keep the middle seats vacant.

Day 1: Over 600 flights cancelled

IT WAS decided on Sunday that Kolkata and Bagdogra airports in cyclone-hit West Bengal will not operate any domestic flight between May 25 and 27 but will handle 20 flights each daily from May 28.

28. Moreover, Vijayawada and Vizag airports in Andhra Pradesh will handle just 20 % of their pre-lockdown flights from May 26.

Mumbai airport, which is India's second busiest airport, will handle only 50 flights daily from Monday, the Centre said, adding Chennai airport will see only 25 arrivals
