India, UAE sign pact to trade in local currencies

"We discussed the full range of India-UAE ties including ways to boost cultural and economic ties," he added. The agreement with the UAE on trade settlement in the currencies of the two countries will boost bilateral trade and investments.

The MoU on establishing a framework for the use of local currencies for transactions between India and UAE aims to put in place a local currency settlement system (LCSS) to promote the use of INR and AED bilaterally.

This arrangement would also promote investments and remittances between the two countries. The use of local currencies would optimise transaction costs and settlement time for transactions, including for remittances from Indians residing in UAE, the statement said.
